Earnings Summary

Portfolio Update

- Total portfolio at fair value \$14.7 billion, compared to \$14.1 billion as of 3/31/2026; 205 portfolio companies, compared to 203 as of 3/31/2026
- Continued strong portfolio company performance
 - No material change to the mix of the overall portfolio risk ratings from 3/31/2026 to 6/30/2026
 - Investments on non-accrual represent approximately 0.6% and 0.1% of the total portfolio at cost and fair value, respectively
- New investment commitments (net of sell downs) of \$0.9 billion and net funded investment activity of \$0.5 billion³

Balance Sheet Update

- \$2.0 billion of liquidity in cash and undrawn debt⁴
- Debt to equity was 0.93x⁵, up from 0.85x⁵ as of 3/31/2026 and within our target range of 0.9x-1.25x
- Debt funding mix comprised of 36.2% unsecured debt (based on outstanding debt)
- Weighted average debt maturity of approximately 5.8 years (based on committed debt)
- Total revolver facility size of \$2.7 billion

Dividends & Repurchase Program

- Q2'26 total dividends of \$0.40 per share and annualized dividend yield of 9.7%⁶
- Total dividends of \$0.40 per share for Q3'26, including a base dividend of \$0.35 per share payable on or before 10/15/2026 and a special dividend of \$0.05 per share payable on or before 10/6/2026
- Repurchased \$55 million in Q2'26 under \$300 million repurchase program

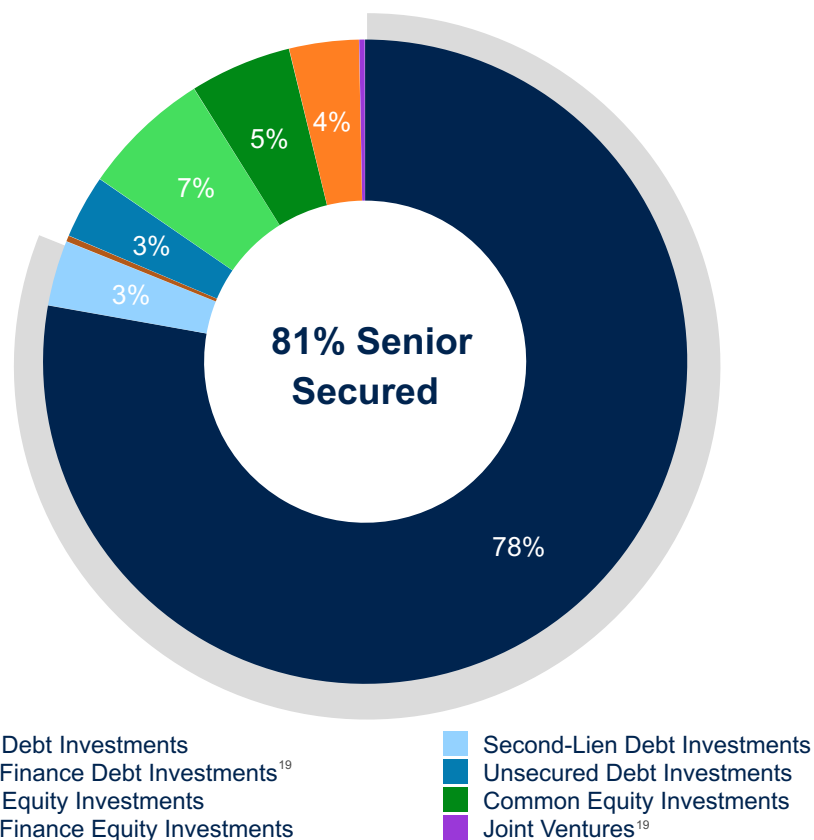

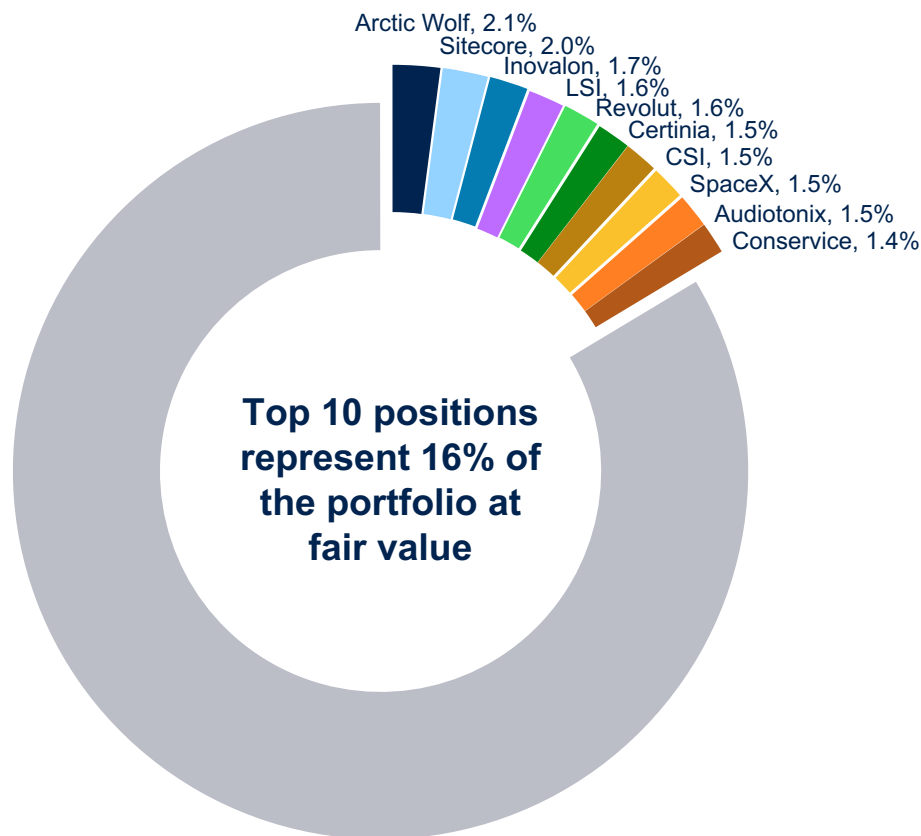

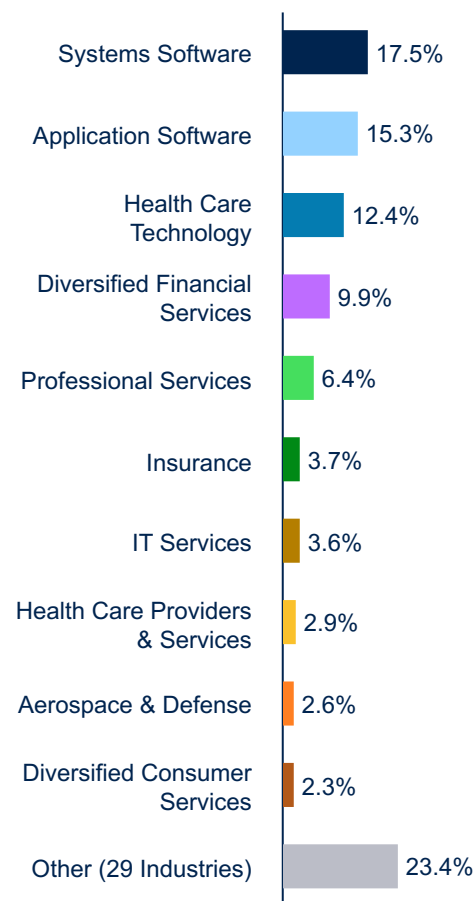
Portfolio Highlights – Diversification

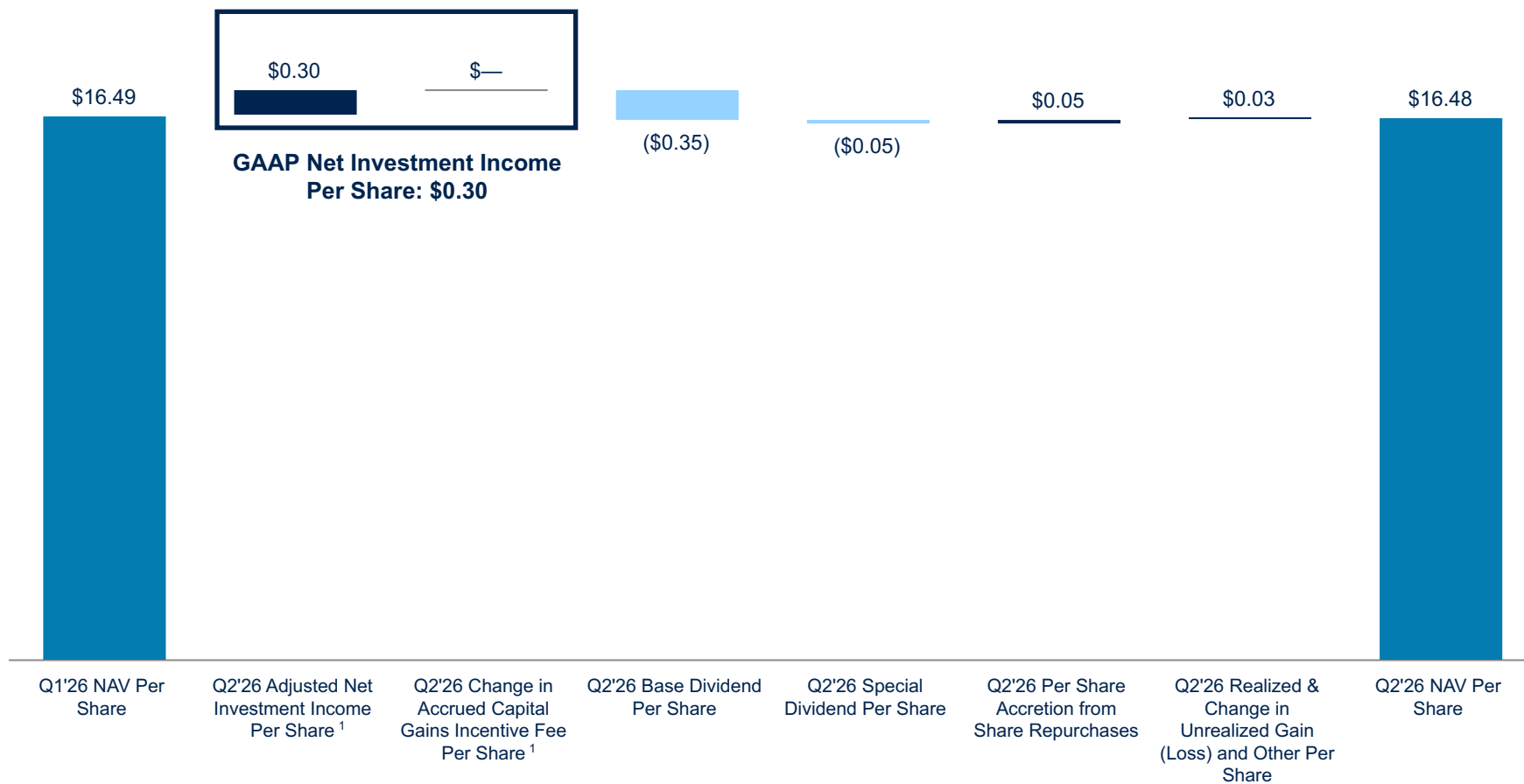

Net Asset Value Per Share Bridge

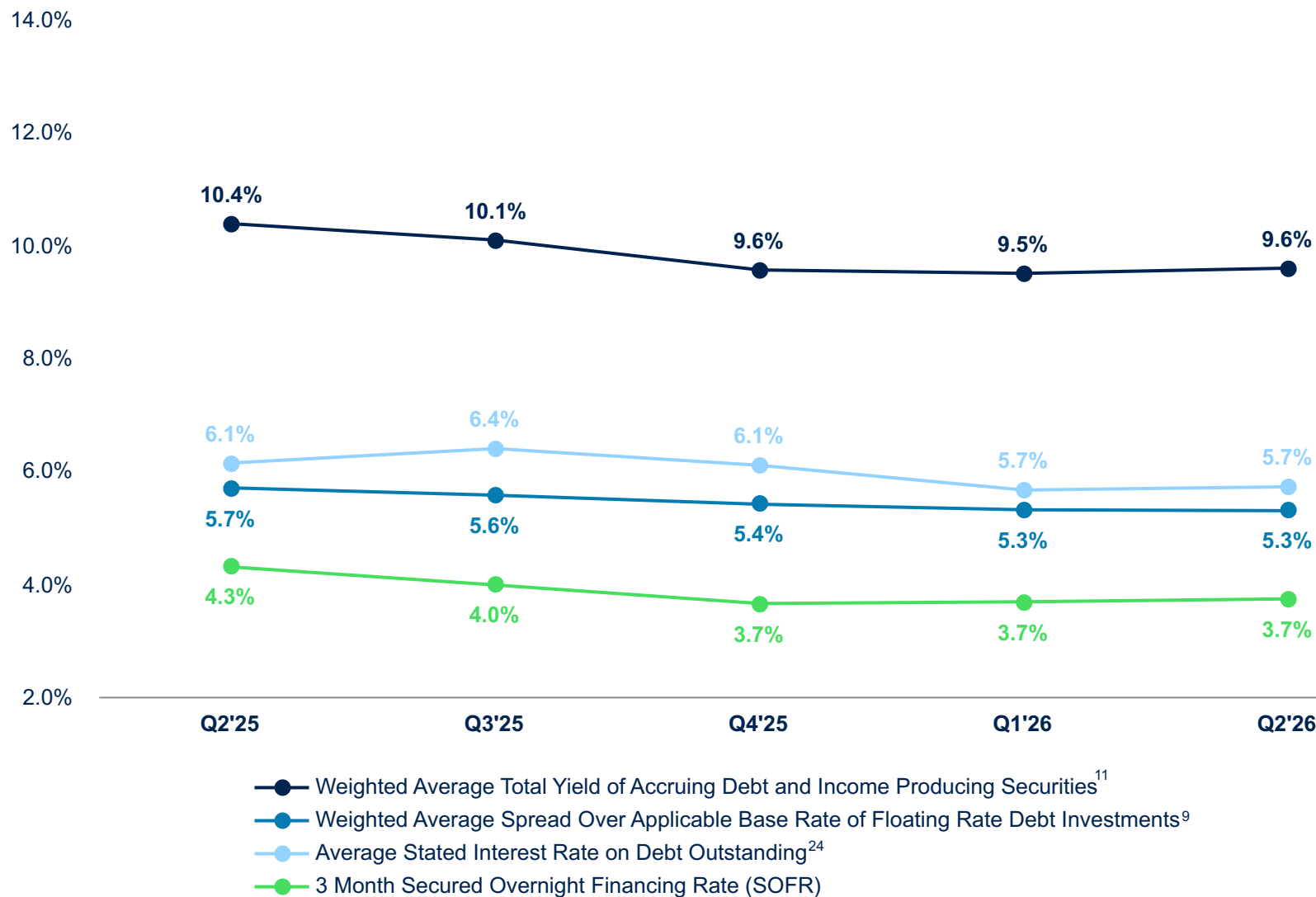

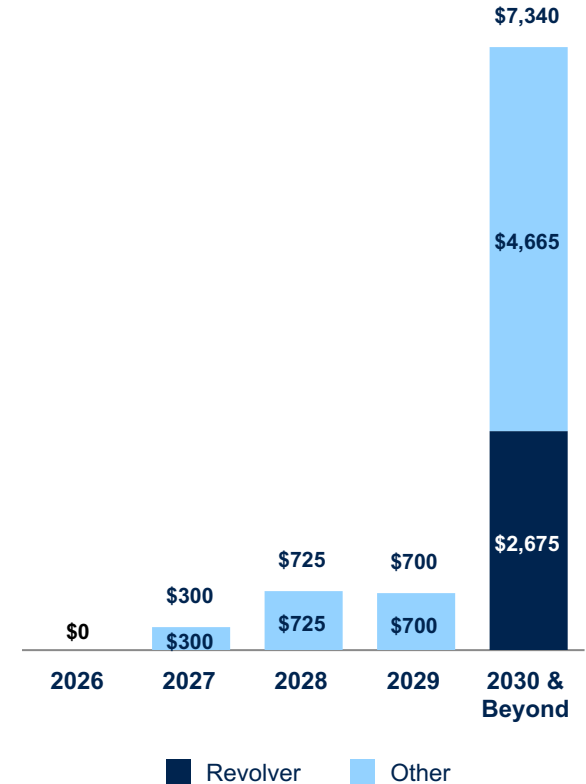

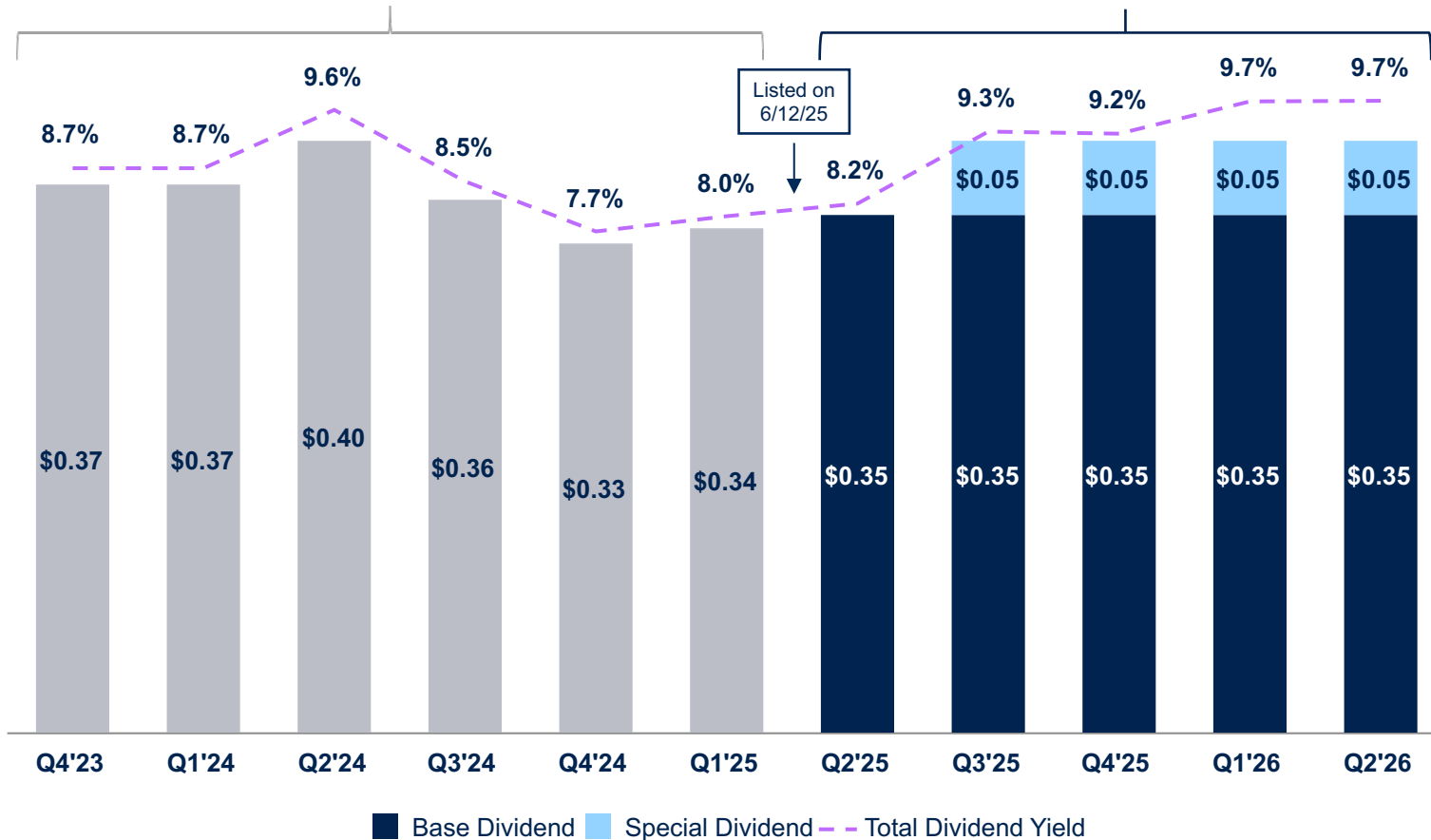
Historical Dividend Yield
